CHAP. 51.

An Act to readjust the Representation in the House of Commons.

[Assented to 12th June, 1914.]

WHEREAS the results of the census of 1911 necessitate R.S., c. 5; a readjustment of the representation in the House of 1907, c. 41. Commons, pursuant to the provisions of *The British North America Act*, 1867, and the other statutes in that behalf: Therefore His Majesty, by and with the advice and consent of the Senate and House of Commons of Canada, enacts as follows:—

- 1. This Act may be cited as The Representation Act, 1914. Short title.
- 2. The House of Commons shall consist of two hundred Number of and thirty-four members, of whom eighty-two shall be members. elected for the province of Ontario, sixty-five for the province of Quebec, sixteen for the province of Nova Scotia, eleven for the province of New Brunswick, fifteen for the province of Manitoba, thirteen for the province of British Columbia, three for the province of Prince Edward Island, sixteen for the province of Saskatchewan, twelve for the province of Alberta, and one for the Yukon Territory.
- 3. The said provinces and territory respectively shall, Division into for the purposes of the election of members to serve in the electoral districts. House of Commons, be divided into electoral districts, and be represented, as provided in the schedule to this Act.
- 4. Every city, town, village, township, parish or place lying Places not within the territorial limits of any electoral district, and mentioned not specifically included in any other electoral district by the said schedule, shall be and be taken to be part of the electoral district in which it is so locally situate.

Interpretation. 5. Wherever in the said schedule any word or expression is used to denote the name of any territorial division, such word or expression shall, unless the context otherwise requires, be construed as indicating such territorial division as it exists and is bounded at the date of the passing of this Act.

Incorrect description.

6. Wherever in the said schedule a municipality or place is wrongly referred to as a city, or a town, or a village, but there is within the territorial limits of the electoral district, in the description of which the reference occurs, a municipality or place of the same name which is a city, or a town, or a village, but is not of the class,—city, town or village, as the case may be,—specified in the schedule, the reference shall be taken to be to that municipality or place.

Commencement of Act. 7. This Act shall take effect only upon the dissolution of the present Parliament.

SCHEDULE.

ONTARIO.

The counties and territorial districts referred to are those constituted by or under chapter 3 of the Revised Statutes of Ontario, 1897, intituled "An Act Respecting the Territorial Division of Ontario for Municipal and Judicial Purposes."

I.

Each of the following counties, with additions and exceptions as and where indicated shall form an electoral district, to be called "the electoral district of (adding the name of the county)", and shall return one member,—

1. The county of Brant, exclusive of the electoral district

of Brantford as hereinafter defined.

2. The county of Carleton, exclusive of that part of the city of Ottawa hereinafter provided as constituting the electoral district of Ottawa, Rideau Ward of the said city, and of the townships of Gloucester and Osgoode.

3. The county of Dufferin.

4. The county of Dundas, with the townships of Finch and Osnabruck, and the village of Finch.

5. The county of Durham.

6. The county of Frontenac, exclusive of the city of Kingston and the village of Portsmouth.

- 7. The county of Glengarry and Stormont, with the townships of Cornwall and Roxborough, and the town of Cornwall.
 - 8. The county of Grenville.
 - 9. The county of Haldimand.

10. The county of Halton.

- 11. The county of Kent, exclusive of the townships of Zone and Camden.
 - 12. The county of Leeds, including the town of Brockville.

13. The county of Lennox and Addington.

- 14. The county of Lanark.
- 15. The county of Lincoln.
- 16. The county of Norfolk.
- 17. The county of Northumberland, exclusive of the township of Monaghan South.
 - 18 The county of Peel.
 - 19. The county of Prescott.

20. The county of Prince Edward.

21. The county of Russell, with the townships of Gloucester and Osgoode, and Rideau Ward of the city of Ottawa.

- 22. The county of Victoria, with the provisional county of Haliburton.
 - 23. The county of Welland.
- 24. The county of Wentworth, with those portions of the city of Hamilton which are not included in the electoral districts of Hamilton East and Hamilton West.

II.

- 25. The territorial district of Muskoka shall constitute the electoral district of Muskoka, and shall return one member.
- 26. The electoral district of Nipissing shall consist of the whole of the territorial district of Nipissing; part of the territorial district of Sudbury, being that part of the territorial district of Sudbury described as follows:-Commencing at the northeast angle of the township of Sladen: thence west along the north boundaries of the townships of Sladen, Selby, Parker, Ellis, Kelly, McLeod, and Stull to the northwest angle of the latter; thence south astronomically along the west limits of the townships of Stull. Valin, Cotton, Beresford, Creelman, Hutton, Wisner, Hammer, Blezard, McKim, Broder, Tilton, townships numbers 60 and 59, and continuing south along the east limit of the township of Humboldt to the southerly limit of the territorial district of Sudbury; thence easterly following the southerly limit of the territorial district of Sudbury to the south limit of the township of Falconer; thence west along the south limit of the township of Falconer to the southwest angle thereof; thence northerly along the easterly limit of the territorial district of Sudbury to the point of commencement: and also the townships of Clara, Head and Maria, in the county of Renfrew, and shall return one member.
- 27. The electoral district of Timiskaming shall consist of the whole of the territorial district of Timiskaming and part of the territorial district of Algoma, together described as follows:—Commencing at a point in the interprovincial boundary in the Ottawa River where it is intersected by the production easterly of the south limit of the township of South Lorrain, said point being the northeast angle of the territorial district of Nipissing; thence west astronomically along the north limit of the said territorial district of Nipissing a distance of ten miles more or less: thence north astronomically along the east boundary of the township of Cassels and along the east boundary of the township north of Cassels a distance of twelve miles more or less; thence west astronomically to the southwest angle of the township of Medina, a distance of thirty miles more or less; thence north astronomically along the west boundary 320 of

of the township of Medina to the northwest angle thereof: thence west astronomically along the north boundary of the townships of Sladen, Selby, Parker, Ellis, McLeod and Stull to the southeast angle of the township of Browning; thence north astronomically along the east limit of the townships of Browning, Ogilvie, Fawcett, MacMurchy, Natal, Mond, Halliday, Hutt, Zavitz, to the northeast angle of the latter, a distance of 54 miles more or less; thence west astronomically along the north boundary of the townships of Zavitz, English, Beemer, Hassard, McBride and Crothers to the northwest angle of the latter, a distance of 36 miles more or less; thence north astronomically along the west boundaries of the townships of Pharand, Hilary. Keefer and Whitesides to the northwest angle of the latter, a distance of 24 miles more or less; thence west astronomically along Niven's base line in latitude 48 degrees 27 minutes 54 seconds north to the southeast angle of the township of Lougheed, a distance of 36 miles more or less; thence north astronomically along the east boundary of the townships of Lougheed, Davin and Buchan to the northeast angle of the latter, a distance of 27 miles more or less; thence continuing north astronomically 23 miles more or less to the intersection of the easterly production of O. L. S. Speight's base line in latitude 49 degrees 12 minutes 6 seconds north; thence west astronomically along said last mentioned production and along said base line to a point in the south limit of the township of Schofield, which lies in the production of a line north astronomically from the northwest angle of the township of Lefroy 50 miles more or less; thence north astronomically along and continuing in the production north from the northwest angle of the township of Lefroy to its intersection with the middle thread of the Albany River; thence northeasterly along the said middle thread of the Albany River to James Bay; thence southeasterly, southerly, easterly and northeasterly following the shore of James Bay to its intersection with the interprovincial boundary between the provinces of Ontario and Quebec: thence southerly along said interprovincial boundary to the point of commencement, and shall return one member.

28. The territorial district of Parry Sound shall constitute the electoral district of Parry Sound, and shall return one member.

29. The city of Brantford, with the township of Oakland, and that part of the township of Brantford south and west of the Grand River, shall constitute the electoral district of Brantford, and shall return one member.

30. The city of Kingston, including the village of Portsmouth, shall constitute the electoral district of Kingston, and shall return one member.

31. The city of London, exclusive of the portions thereof described as follows: (1) Lands and premises formerly in the township of London, now in said city, viz.: the south halves of lot numbers eleven and twelve in concession two of the township of London, now in said city, including the road allowance south and west of the said south halves, and annexed to the said city as of the twenty-first day of December, A.D. 1912. (2) Lands and premises formerly in the township of London, now in said city, viz.: Commencing on the southerly limit of Oxford Street, otherwise known as the allowance for road between concessions one and two of the said township of London; thence easterly along said southerly limit of Oxford Street, or to the said allowance for road to the easterly limit of lot number eight in the first concession of the said township of London: thence southerly and along the limit between lots numbers seven and eight in concessions one and "C" of the said township of London, to the northerly limit of the allowance for road between concessions "C" and "B" of the said township; thence westerly along the northerly limit of the said last mentioned allowance to the westerly limit of the allowance for road between lots numbers twelve and thirteen in the said township; thence southerly along the said westerly limit of the said road allowance to the River Thames: thence easterly and southerly following the said River Thames to the westerly limit of the allowance for road between lots numbers eight and nine in concessions "A" and "B" of said township, and thence northerly along the western limit of the said last mentioned road to the northern limit of the allowance for road between said concessions "B" and "C," and annexed to the city of London as of the twenty-first day of December, A.D. 1912. (3) Lands and premises formerly in the township of Westminster, now in the said city, namely: particularly described as follows, that is to say: Commencing at the intersection of the eastern limit of lot number twenty-two in the broken front concession of the township of Westminster with the River Thames; thence southerly along said eastern limit of the said lot to the base line of said township; thence westerly along the northerly limit of said base line to the London and Port Stanley Railway track; thence northerly along the said railway track to the Whetter Road; thence westerly along the northern limit of the Whetter Road to the former eastern boundary of the city of London; thence northerly along the said former eastern boundary of the said city of 322 London

London to the River Thames; thence easterly along the River Thames to the place of commencement, and more generally known as Chelsea Green, and annexed to the city of London as of the twenty-first day of December, A.D. 1912. (4) Lands and premises formerly in the township of London, now in said city of London, viz: being described as that portion of lot number eight in the first concession of the said township of London now in said city. lving north of Dundas Street and west of sub-lot number one in registered plan number nineteen, and southeast of the line of the Grand Trunk Railway, and those portions of lots six and seven in the first concession of the said township of London, now in said city, consisting of sub-lots numbers one, two, three, four, five, six, thirteen, fourteen, fifteen, nineteen, twenty, twenty-one, twenty-five, twenty-six, twenty-seven and thirty-one, in said registered plan number nineteen, and annexed to the city of London under Railway and Municipal Board order dated ninth of April, A.D. 1913; shall constitute the electoral district of London, and shall return one member.

32. The city of Ottawa, exclusive of that part thereof. described as follows:—Commencing at a point where the original line between lots thirty-three and thirty-four intersects the southerly limit of the Canadian Pacific Railway, said point being the extreme northwesterly point of the city, thence southeasterly along the said dividing line between lots thirty-three and thirty-four to the south side of Carling Avenue, thence easterly along the southerly limit of Carling Avenue to its intersection with the westerly limit of the St. Lawrence and Ottawa branch of the Canadian Pacific Railway, thence northerly along the westerly limit of the said railway to the centre of Somerset Street. thence westerly along the centre of Somerset Street to the centre of Bayswater Avenue, thence northerly along the centre of Bayswater Avenue and Bayview Road to the centre of Mason Street, thence northerly along the centre of Mason Street and Mason Street produced to its intersection with the interprovincial boundary line, thence westerly along the interprovincial boundary line to Parkdale Avenue produced, thence southerly along Parkdale Avenue to its intersection with the northerly side of Scott Street, thence westerly along the northerly side of Scott Street to Skead's Road, the place of commencement, comprising that part of the city of Ottawa formerly known as Hintonburgh, Bayswater and Mechanicsville, and also exclusive of Rideau Ward; shall constitute the electoral district of Ottawa. and shall return two members.

III.

The following counties, cities, and territorial districts, with additions and exceptions as and where indicated, shall be divided as follows; each riding to be an electoral district, and each electoral district to return one member:—

- 33. The territorial district of Algoma, excepting part thereof hereinbefore allotted to the electoral district of Temiskaming; that part of the territorial district of Sudbury lying west of the easterly limits of townships No. 67, No. 68, No. 69, Waters, Snider, Rayside, Lumsden, and a line drawn north astronomically from the northeast angle of the last mentioned township; and the territorial district of Manitoulin, shall form and constitute the electoral district of Algoma and shall be divided into two ridings to be called respectively the east and the west ridings of Algoma.
- (a) The east riding shall consist of parts of the territorial districts of Algoma and Sudbury, and the whole of the territorial district of Manitoulin, described as follows:— Commencing at a point in the southerly limit of the territorial district of Algoma, where it is intersected by the production in a straight line southerly of the limit between the townships of Lefroy and Plummer Additional; thence north along said production and along the said limit to the northwest corner of the said township of Lefroy; thence due north to the southerly limit of the township of Schofield; thence east astronomically along O. L. S. Speight's base line in latitude 49 degrees 12 minutes 6 seconds north, and continuing east astronomically in the production thereof 50 miles more or less to the intersection with a line drawn north astronomically from the northeast angle of the township of Buchan; thence south astronomically 23 miles more or less to the northeast angle of the said township of Buchan; thence continuing south astronomically along the east limits of the townships of Buchan, Davin and Lougheed 27 miles more or less to the southeast angle of the latter; thence east astronomically along O. L. S. Niven's base line in latitude 48 degrees 27 minutes 54 seconds north 36 miles more or less to the northwest angle of the township of Whitesides; thence south astronomically along the west limit of the townships of Whitesides, Keefer, Hilary and Pharand 24 miles more or less to the southwest angle of the latter; thence east astronomically along the north limits of the townships of Crothers, McBride, Hassard, Beemer, English, and Zavitz to the northeast angle of the latter; thence south astronomically along the east limits of the townships of Zavitz, Hutt, Halliday, Mond, Natal, MacMurchy, Fawcett.

Fawcett, Ogilvie, Browning, Unwin, Leask, McNamara, Beaumont, Roberts, Kitchener, Bowell, Lumsden, Rayside, Snider, Waters, Townships 69, 68, 67 and township of Humboldt; thence southerly, westerly and northwesterly following the easterly, southerly and westerly limits of the territorial district of Manitoulin to the intersection of the southerly limit of the territorial district of Algoma at the international boundary between the province of Ontario and the United States of America; thence westerly along said international boundary and along the southerly limit of the territorial district of Algoma to the point of intersection in Lake Huron with said international boundary with the southerly production of the limit between the townships of Lefroy and Plummer Additional, being the point of commencement.

(b) The west riding shall consist of the tract of territory described as follows:—All the remaining portion of the territorial district of Algoma and Sudbury lying west of a line drawn north astronomically from the northwest angle of the township of Lefroy to the intersection with the middle thread of the Albany River.

34. The county of Bruce into two ridings, to be called respectively the north and the south ridings of Bruce.

(a) The north riding shall consist of the townships of Albemarle, Amabel, Arran, Bruce, Eastnor, Kincardine, Lindsay, Saugeen, and St. Edmunds, the towns of Kincardine and Wiarton, and the villages of Port Elgin, Southampton, Tara and Tiverton.

(b) The south riding shall consist of the townships of Brant, Carrick, Culross, Elderslie, Greenock, Huron and Kinloss, the town of Walkerton, and the villages of

Chesley, Lucknow, Paisley and Teeswater.

35. The county of Elgin into two ridings, to be called

respectively the east and west ridings of Elgin.

(a) The east riding shall consist of the townships of Bayham, Dorchester South, Malahide and Yarmouth, the town of Aylmer, and the villages of Port Stanley, Springfield and Vienna.

(b) The west riding shall consist of the townships of Aldborough, Dunwich and Southwold, the city of St. Thomas, the town of Dutton, and the villages of Rodney and West Lorne.

36. The county of Essex into two ridings, to be called respectively the north and the south ridings of Essex.

(a) The north riding shall consist of the townships of Maidstone, Rochester, Sandwich East, Sandwich South and Sandwich West, the city of Windsor, the towns of Sandwich, Walkerville and Objibway, and the villages of Belle River and Ford City.

(b) The south riding shall consist of the townships of Anderdon, Colchester North, Colchester South, Gosfield North, Gosfield South, Malden, Mersea, Pelee, Tilbury North. Tilbury West, the towns of Amherstburg, Essex, Kingsville and Leamington, and that portion of the village of Tilbury and that portion of the village of Wheatley lying in the county of Essex.

37. The territorial districts of Thunder Bay, Kenora and Rainv River into two ridings, to be called respectively Fort William and Rainy River, and Port Arthur and Kenora.

- (a) The electoral district of Fort William and Rainv River shall consist of those parts of the territorial districts of Kenora, Rainy River, and Thunder Bay described as follows, viz.: Commencing on the international boundary between the province of Ontario and the United States of America at a point on the westerly boundary of the district of Kenora astronomically west from a point five miles astronomically south from the station of the Canadian Pacific Railway at Ignace in the said district; astronomically east to a point distant five miles from the line of the Canadian Pacific Railway; thence in a southeasterly direction parallel with the line of the Canadian Pacific Railway and five miles distant therefrom to the northerly boundary of the township of Conmee in the district of Thunder Bay or the projection thereof astronomically west: thence east along the north boundary of the townships of Conmee and Clover to the northeast angle of the township of Oliver; thence south astronomically along the east limit of said township of Oliver to the north limit of the township of Paipoonge, thence east astronomically along the north limit of said township of Paipoonge, and along the north limit of the township of Neebing, to the west shore of Thunder Bay of Lake Superior, thence continuing due east eight miles, more or less, to a point due north astronomically from the most easterly point of Pie Island in said Bay, thence due south astronomically twenty miles, more or less, to the said international boundary, thence scuthwesterly along said international boundary to the mouth of Pigeon River, thence continuing westerly along said international boundary to the place of beginning.
- (b) The electoral district of Port Arthur and Kenora shall consist of the territorial districts of Thunder Bay, Kenora and Rainy River, exclusive of the parts thereof included in the description herein of the electoral district of Fort William and Rainy River; and of the district of Patricia.
- 38. The county of Grey into two ridings, to be called respectively the north and the southeast ridings of Grey. 326 (a)

(a) The north riding shall consist of the towns of Owen Sound, Meaford and Thornbury, and the townships of Sydenham, Keppel, Derby, Sarawak, St. Vincent, Collingwood and Euphrasia.

(b) The southeast riding shall consist of the towns of Durham and Hanover, and the villages of Markdale, Dundalk, Flesherton and Chatsworth, and the townships of Bentinck, Normandy, Glenelg, Egremont, Proton, Artemesia, Osprey,

Holland and Sullivan.

39. The county of Hastings into two ridings, to be called

respectively the east and west ridings of Hastings.

- (a) The east riding shall consist of the townships Thurlow, Tyendinaga, Hungerford, Madoc, Elzevir and Grimsthorpe, Tudor, Cashel, Limerick, Dunganan, Mayo, Monteagle and Carlow; the town of Deseronto, and the villages of Madoc and Tweed.
- (b) The west riding shall consist of the townships of Sydney, Rawdon, Huntingdon, Marmora and Lake, Wollaston, Farraday, Herschel, McClure, Wicklow and Bangor, the city of Belleville, the town of Trenton, and the villages of Marmora and Stirling.

40. The county of Huron into two ridings, to be called respectively the north and the south ridings of Huron.

- (a) The north riding shall consist of the townships of Wawanosh East, Wawanosh West, Colborne, Ashfield, Turnberry, Morris, Howick, and Grey, the towns of Goderich and Wingham, and the villages of Blyth, Brussels, and Wroxeter.
- (b) The south riding shall consist of the townships of Hay, McKillop, Stanley, Stephen, Tuckersmith, Usborne, Hullet and Goderich, the towns of Clinton and Seaforth, and the villages of Hensall, Exeter and Bayfield.

41. The county of Lambton and the townships of Zone and Camden in the county of Kent into two ridings, to be called respectively the east and the west ridings of Lambton.

- (a) The east riding shall consist of the townships of Bosanquet, Brooke, Enniskillen, Euphemia, Zone, Camden and Warwick, and the towns of Forest and Petrolia, and the villages of Alvinston, Arkona, Oil Springs, Thedford and Watford.
- (b) The west riding shall consist of the townships of Dawn, Moore, Plymton, Sarnia and Sombra, the town of Sarnia, and the villages of Point Edward and Wyoming.
- 42. The county of Middlesex, exclusive of that part of the city of London hereinbefore provided as constituting the electoral district of London, into two ridings, to be called respectively the east and the west ridings of Middlesex.

(a) The east riding shall consist of the townships of Dorchester North, London, Nissouri West, Westminster and 327 Biddulph,

Biddulph, the village of Lucan and those portions of the city of London not included in the electoral district of the

city of London as defined hereinbefore.

(b) The west riding shall consist of the townships of Adelaide, Lobo, Delaware, Caradoc, Metcalfe, Mosa, Ekfrid, McGillivray, Williams East and Williams West, the towns of Park Hill and Strathroy, and the villages of Ailsa Craig, Glencoe, Newbury and Wardsville.

43. The county of Ontario into two ridings, to be called

respectively the north and the south ridings of Ontario.

(a) The north riding shall consist of the townships of Brock, Mara, Rama, Scott, Thora and Uxbridge, the town of Uxbridge, and the villages of Beaverton and Cannington.

(b) The south riding shall consist of the townships of Pickering, Reach, Scugog, Whitby and Whitby East, the towns of Oshawa and Whitby, and the village of Port Perry.

44. The county of Oxford into two ridings, to be called respectively the north and the south ridings of Oxford.

(a) The north riding shall consist of the townships of Blandford, Blenheim, Nissouri East, Zorra East and Zorra West, the city of Woodstock, that part of the village of Tavistock situated in the township of Zorra East, and the village of Embro.

(b) The south riding shall consist of the townships of Dereham, Norwich North, Norwich South, Oxford East, Oxford North and Oxford West, the towns of Ingersoll and

Tillsonburg, and the village of Norwich.

45. The county of Perth, into two ridings, to be called respectively the north and the south ridings of Perth.

- (a) The north riding shall consist of the townships of Easthope North, Ellice, Elma, Mornington, and Wallace, the city of Stratford, the town of Listowel, and the village of Milverton.
- (b) The south riding shall consist of the townships of Blanchard, Downie, Easthope South, Fullerton, Hibbert and Logan, and the towns of Mitchell and St. Mary's and that part of the village of Tavistock situated in the township of Easthope South.

46. The county of Peterborough, with the township of Monaghan South, into two ridings, to be called respectively

the east and the west ridings of Peterborough.

(a) The east riding shall consist of the townships of Anstruther, Asphodel, Belmont, Burleigh, Chandos, Douro, Dummer, Methuen and Otonabee, and the villages of Havelock, Lakefield and Norwood.

(b) The west riding shall consist of the townships of Cavendish, Ennismore, Galway, Harvey, Monaghan North, Monaghan South and Smith, and the city of Peterborough.

47. The county of Renfrew, exclusive of the townships of Clara, Head and Maria, into two ridings, to be called respectively the north and the south ridings of Renfrew.

(a) The north riding shall consist of the townships of Algona North, Algona South, Alice, Bromley, Buchanan, Fraser, McKay, Pembroke, Petewawa, Rolph, Ross, Stafford, Westmeath, Wilberforce and Wylie, the town of Pembroke, the village of Cobden, and so much of the village of Eganville as lies within the township of Wilberforce.

(b) The south riding shall consist of the townships of Adamston, Bagot, Blithfield, Brougham, Brudenell, Burns, Grattan, Griffith, Hagarty, Horton, Jones, Lyndoch, Matawachan, McNab, Ratcliffe, Raglan, Richards, Sebastapol and Sherwood, the towns of Arnprior and Renfrew and so much of the village of Eganville as lies within the township of Grattan.

48. The county of Simcoe into three ridings, to be called respectively the east, the north and the south ridings of

Simcoe.

- (a) The east riding shall consist of the townships of Matchedash, Medonte, Orillia North, and Orillia South, Tay and Tiny, and the towns of Midland, Orillia and Penetanguishene, and the villages of Coldwater and Victoria Harbour.
- (b) The north riding shall consist of the townships of Flos, Nottawasaga, Oro, Sunnidale, and Vespra, the towns of Collingwood and Stayner, and the village of Creemore.
- (c) The south riding shall consist of the townships of Adjala, Essa, Gwillimbury West, Innisfil, Tecumseh and Tossorontio, the towns of Alliston and Barrie, and the villages of Beeton, Bradford and Tottenham.

49. The county of Waterloo into two ridings, to be called respectively the north and the south ridings of

 \mathbf{W} aterloo.

(a) The north riding shall consist of the townships of North Waterloo, Wellesley and Woolwich, the city of Berlin, the town of Waterloo, and the village of Elmira.

(b) The south riding shall consist of the townships of North Dumfries, South Waterloo and Wilmot, and the towns of Ayr, Galt, Hespeler, New Hamburg and Preston.

The township of Waterloo shall be divided, for the purposes of representation, into two townships, to be called respectively the township of North Waterloo and the township of South Waterloo: The township of North Waterloo shall include and consist of that part of the township of Waterloo lying within the following limits, that is to say:—Commencing at the southwest angle of lot number forty-six in said township, thence easterly along the south-

erly limits of said lot, and of lots number forty-seven, forty-eight, fifty, fifty-one, and fifty-three, and the prolongation thereof, to the middle of the Grand River; thence along the middle of the said river against the stream to the prolongation of the limit between lots number one hundred and thirteen and one hundred and fourteen. and along the prolongation of the limit between said lots number one hundred and thirteen and one hundred and fourteen, and along the limit between said lots number one hundred and thirteen and one hundred and fourteen northerly and easterly, to the westerly limit of lot number one hundred and seven; thence along the westerly limit of said number one hundred and seven, northerly, to the northerly limit thereof; thence along the northerly limits of said lot number one hundred and seven, and of lots number one hundred and six, eighty-four and ninety-six, easterly, to the easterly boundary of said township; thence along the easterly, northerly and westerly boundaries of said township, in a northerly, westerly and southerly direction respectively, to the place of beginning: And the township of South Waterloo shall include and consist of all the remaining part of the said township of Waterloo.

50. The county of Wellington into two ridings, to be called respectively the north and the south ridings of

Wellington.

(a) The north riding shall consist of the townships of Arthur, Garafraxa West, Luther West, Maryborough, Minto and Peel, the towns of Harriston, Mt. Forest and Palmerston, and the villages of Arthur, Clifford and Drayton

(b) The south riding shall consist of the townships of Eramosa, Erin, Guelph, Nichol, Pilkington and Puslinch, the city of Guelph and the villages of Elora, Erin and Fergus.

- 51. The city of Toronto, exclusive of those portions thereof allotted to the electoral districts of East York, West York and South York as hereinafter defined, into six electoral districts as follows:
- (a) The electoral district of Toronto South shall consist of all that portion of the city of Toronto, including Toronto Island, which lies to the south and west of a line described as follows:—Commencing at the southern limit of the city of Toronto where it is intersected by the production southerly of the centre line of the River Don Roadway on the west side of the River Don; thence northwesterly along the said production and the said centre line to the centre line of Queen Street East; thence westerly along the centre line of Queen Street, East and West, and its production westerly to the south limit of the said city of Toronto.

(b) The electoral district of Toronto East shall consist of that portion of the city of Toronto described as follows: Commencing at the southern limit of the city of Toronto where it is intersected by the production southerly of the centre line of the River Don Roadway on the west side of the River Don; thence northwesterly along the said production and said centre line to the centre line of Queen Street East, thence westerly along the centre line of Queen Street East to the centre line of Sherbourne Street, thence northerly along the centre line of Sherbourne Street to the centre line of Bloor Street; thence easterly along the centre line of Bloor Street and Bloor Street East produced easterly to the centre line of Danforth Avenue; thence continuing along the centre line of Danforth Avenue to the centre line of Pape Avenue; thence southerly along the centre line of Pape Avenue to the southern limit of the city of Toronto; thence westerly along the southern limit of the city of Toronto to the point of commencement.

(c) The electoral district of Toronto Centre shall consist of all that portion of the city of Toronto described as follows: Commencing at the point of intersection of the centre line of Queen Street West by the centre line of Spadina Avenue; thence northerly along the centre line of Spadina Avenue to the centre line of Bloor Street West; thence easterly along the centre line of Bloor Street West and Bloor Street East to the centre line of Sherbourne Street; thence southerly along the centre line of Sherbourne Street to the centre line of Queen Street East; thence westerly along the centre line of Queen Street East and Queen Street West to the

point of commencement.

(d) The electoral district of Toronto West shall consist of all that portion of the city of Toronto described as follows:—Commencing at the point of intersection of the centre line of Queen Street West with the centre line of Spadina Avenue; thence northerly along the centre line of Spadina Avenue to the centre line of Bloor Street West; thence westerly along the centre line of Bloor Street West to the centre line of Dovercourt Road; thence southerly along the centre line of Dovercourt Road to the centre line of Queen Street West; thence easterly along the centre line of Queen Street West to the point of commencement.

(e) The electoral district of Parkdale shall consist of all that portion of the city of Toronto described as follows:—Commencing at a point where the western limits of the city of Toronto intersect Bloor Street West at the north-western corner of High Park; thence southerly along the western city limits to the southern city limits; thence easterly along the southern city limits to the intersection

with the centre line of Queen Street West produced: thence easterly along the centre line of Queen Street West to the centre line of Dovercourt Road; thence northerly along the centre line of Dovercourt Road to the southern boundary of the right of way of the Canadian Pacific Railway; thence westerly along the southern boundary of the Canadian Pacific Railway right of way to the boundary of Ward 7: thence along the easterly and southerly boundary of Ward 7 to the point of commencement.

- (f) The electoral district of Toronto North shall consist of all that portion of the city of Toronto described as follows:—Commencing at the intersection of the northern limit of the city of Toronto with the centre line of Oakwood Avenue: thence southerly along Oakwood Avenue to the centre line of Davenport Road; thence westerly along the centre line of Davenport Road to the centre line of Dovercourt Road produced: thence southerly along the centre line of Dovercourt Road produced and Dovercourt Road to the centre line of Bloor Street West; thence easterly along the centre line of Bloor Street West and East and the centre line of Bloor Street East produced to its point of intersection with the western limit of the right of way of the Grand Trunk Railway (known as the Belt Line); thence northerly along the said western limit of the said Belt Line Railway to its intersection of the northern limit of the city of Toronto as defined by the southerly limit of Township Lot 19 concession 3 from the Bay; thence westerly along said limit and its production westerly to the easterly limit of Township Lot 21 in the 3rd concession from the Bay; thence northerly along that limit to the southerly limit of the former town of North Toronto; thence westerly along that limit and its westerly production to a line 130 feet westerly from the westerly limit of Oriole Parkway and parallel thereto; thence southerly along that line to the northerly limit of the city according to the Ontario Proclamation dated March 3rd, 1905; thence following the present limits of the city to the centre line of Oakwood Avenue, the point of commencement.
- 52. The county of York, including parts of the city of Toronto as hereinafter defined is divided into four ridings, to be called respectively the east, the west, the south and the north ridings of York.
- (a) The east riding shall consist of the township of Scarboro, and that portion of the city of Toronto described as follows:-Commencing at the point of intersection of the centre line of Danforth Avenue with the centre line of Pape Avenue; thence easterly along the centre line of Danforth Avenue to its intersection with the easterly limits of the 332 city

city of Toronto; thence southerly, easterly and southerly along the eastern limits of the city of Toronto to the southern limits of the city of Toronto; thence westerly along the southerly limits of the city of Toronto to its intersection with the centre line of Pape Avenue produced southerly; thence northerly along the centre line of Pape Avenue produced southerly and the centre line of Pape Avenue to the point of commencement.

(b) West York shall consist of the townships of Vaughan and Etobicoke and the villages of Weston, New Toronto, Mimico and Woodbridge and Ward 7 of the city of Toronto; and that portion of the township of York lying between the westerly limit of the city of Toronto and the township of Etobicoke bounded on the south by the shore of Lake Ontario and bounded on the north by the centre line of Northland Avenue produced westerly to a point where the said line intersects the eastern boundary of the township of Etobicoke.

(c) South York shall consist of the villages of Richmond Hill, and Markham, the township of Markham, the town of Leaside, and the township of York save and except those portions included in the riding of West York; and those portions of the city of Toronto not included in the ridings of West York, Parkdale, North Toronto, East Toronto, Centre Toronto, West Toronto, South Toronto and East York.

(d) The north riding shall consist of the townships of Georgina, Gwillimbury East, Gwillimbury North, King and Whitchurch, the towns of Aurora and Newmarket, and the villages of Holland Landing, Sutton and Stouffville.

53. The city of Hamilton, exclusive of those parts thereof allotted to the electoral district of Wentworth, into two electoral districts, to be called respectively the east and

the west ridings of Hamilton.

(a) The east riding shall consist of that part of the city of Hamilton described as follows:-Commencing at the intersection of the centre line of Ottawa street, (being the road allowance between lots numbers four and five of the township of Barton) with the waters' edge of Burlington Bay; thence southerly along the centre of Ottawa street to Burlington street, (being the road allowance between the Broken Front and first concession of the township of Barton); thence westerly along the centre of said Burlington street to the division line between lots numbers five and six of the township of Barton; thence southerly along the said division line between lots numbers five and six to Barton street (being the road allowance between concessions one and two of the township of Barton); thence westerly along the centre of said Barton street to Sherman avenue, (being the road allowance between lots numbers 333 eight eight and nine of the township of Barton); thence southerly along the centre of said Sherman avenue to the brow of the mountain; thence westerly along the brow of the mountain to Wentworth street (being the road allowance between lots numbers ten and eleven of the township of Barton). thence southerly along the centre of said Wentworth street to Aberdeen avenue, (being the road allowance between concessions three and four of the township of Barton); thence westerly along the centre of said Aberdeen avenue to a point where the said Aberdeen avenue would be intersected by the centre line of Ferguson avenue produced southerly; thence northerly along the said production of the said centre line of Ferguson avenue, and the centre of said Ferguson avenue, to King street; thence westerly along the centre of King street to Hughson street; thence northerly along the centre of Hughson street and the production of the centre line thereof to the waters of Burlington Bay; thence easterly along the waters' edge of

Burlington Bay to the place of beginning.

(b) The west riding shall consist of that part of the city of Hamilton described as follows:-Commencing at the intersection of Dundurn street, (being the road allowance between lots numbers eighteen and nineteen of the township of Barton) with the brow of the mountain; thence northerly along the centre of said Dundurn street to Aberdeen avenue. (being the road allowance between concessions three and four of the township of Barton); thence westerly along the centre of said Aberdeen avenue to Paradise road, (being the road allowance between lots numbers twenty and twenty-one of the township of Barton); thence northerly along the centre of said Paradise road to the waters of the marsh (generally known as Cootes Paradise); thence along the southerly and easterly margins of the said marsh to the waters of Burlington Bay; thence easterly along the southerly margin of Burlington Bay to a point where the centre line of Hughson street produced northerly would intersect with the waters of Burlington Bay; thence southerly along the said centre line of Hughson street produced northerly and continuing along the centre of Hughson street to King street; thence easterly along the centre of King street to Ferguson avenue; thence southerly along the centre of Ferguson avenue and the production southerly of the centre line thereof, to Aberdeen avenue, (being the road allowance between concessions three and four of the township of Barton); thence westerly along the centre of said Aberdeen avenue to the mountain brow; thence westerly along the mountain brow to the place of beginning.

QUEBEC. .

The electoral districts of the province of Quebec shall continue to be constituted and represented in the House of Commons, as at present, except in the following particulars:—

1. The two counties of Vaudreuil and Soulanges shall be united and form one electoral district to be called Vaudreuil-Soulanges, and shall return one member.

2. The two counties of Châteauguay and Huntingdon shall be united and form one electoral district to be called Châteauguay-Huntingdon, and shall return one member.

3. The electoral district of Rimouski shall be divided into two electoral districts, each returning one member, as

follows:—

(a) One which is to be called Rimouski, and which shall comprise all that part of the present county of Rimouski situated west of the Métis river together with the whole of the parish of Ste. Angèle de Mérici.

(b) One called Matane, comprising all that part of the present county of Rimouski situated east of the Métis river less that portion of the parish of Ste. Angèle de Mérici

which is situated east of the Métis river.

4. The parishes of St. Tite, St. Féréol, St. Joachim, Château Richer, Ste. Anne and the village of Ste. Anne shall be detached from the electoral district of Montmorency and shall be transferred to the electoral district of Charlevoix, and together with the said electoral district of Charlevoix shall form one electoral district to be called Charlevoix-Montmorency, and shall return one member.

5. The parishes of L'Ange Gardien, Laval and all the parishes and municipalities of the island of Orleans shall be transferred from the present electoral district of Mont-

morency to the electoral district of Quebec County.

6. The electoral districts of Quebec Centre, Quebec East and Quebec West shall cease to exist as such and three new electoral districts shall be created as follows:

- (a) The electoral district of Quebec South which shall consist of the following wards of the city of Quebec: Champlain, St. Peter's, Palace, St. Louis, Montcalm and Belvedere, together with the parish of Sillery, which shall be transferred from the county of Quebec to the said electoral district of Quebec South.
- (b) The electoral district of Quebec East which shall consist of the following wards of the city of Quebec to wit: St. John, Jacques Cartier, St. Roch and Limoilou.
- (c) The electoral district of Quebec West which shall consist of the following wards of the city of Quebec to wit: St. Sauveur, St. Valier, Stadacona, St. Malo, Petite Rivière,

and the parishes of Ste. Fove and St. Félix du Cap Rouge. together with the parishes of St. Augustin, Les Ecureuils and Neuville (which is also called Pointe aux Trembles) which shall be transferred from the electoral districts of Quebec County and Portneuf to the said electoral district of Quebec West.

Each of the said new electoral districts of Quebec East, Quebec West and Quebec South shall return one member.

- 7. The County of Quebec without Sillery, Ste. Foye, and St. Félix du Cap Rouge, but with L'Ange Gardien, Laval, and the island of Orleans, shall form one electoral district, and shall return one member.
- 8. The electoral district of Portneuf less St. Augustin, Neuville and Les Ecureuils which shall be, as hereinbefore specified, transferred to the electoral district of Quebec West, but with La Tuque and that portion of the territory extending northward of the present north boundary of Portneuf, which is situated east of the northwesterly production of the line which now forms the boundary between the counties of Champlain and Portneuf (which shall be transferred from the county of Champlain to the said electoral district of Portneuf), shall form one electoral district, and shall return one member.
- 9. All the parishes, municipalities and towns comprised in the electoral district of Laval and situated on Isle Jésus, and the electoral district of Two Mountains, shall form one electoral district which shall be called Laval-Two Mountains, and shall return one member.
- 10. The island of Montreal shall form twelve electoral districts, each returning one member, and shall be as follows:
- (a) The electoral district of Jacques Cartier which shall be constituted as at present less the town of Verdun, Outremont, Côte-des-Neiges ward, the town of Mount Royal, and Mount Royal ward which shall be transferred to another electoral district as hereinafter specified, the said electoral district of Jacques Cartier to comprise, however, as at present, all that part of Bordeaux which is situated to the west of the line of the Canadian Pacific Railway; also that part of St. Gabriel ward north of the said Grand Trunk Railway tracks as hereinafter described.
- (b) The electoral district of St. Ann which shall consist of the whole of Centre, West and St. Ann's wards of the city of Montreal, the southern part of St. Gabriel ward (said southern part being separated from the northern part by the Grand Trunk Railway tracks) of the said city of Montreal, and the whole of the parish and town of Verdun 336 which

which shall be transferred from the county of Jacques Cartier to the said St. Ann electoral district.

(c) The electoral district of George-Etienne Cartier which shall consist of the whole of St. Louis and St. Jean-Baptiste

wards of the city of Montreal.

(d) The electoral district of Laurier-Outremont which shall consist of the whole of Laurier and Outremont wards, Côte-des-Neiges ward, the town of Mount Royal, Mount Royal ward and Mount Royal Park of the city of Montreal.

(e) The electoral district of St. James which shall comprise the whole of East, Lafontaine and St. James wards

of the city of Montreal.

(f) The electoral district of St. Mary which shall be composed of the whole of Papineau and St. Mary's wards of the city of Montreal.

(g) The electoral district of Hochelaga which shall comprise the whole of Hochelaga, Duvernay and Delorimier

wards of the city of Montreal.

(h) The electoral district of St. Denis which shall be composed of the whole of St. Denis ward, Ahuntsic and all that part of Bordeaux situated to the east of the line of the

Canadian Pacific Railway.

- (i) The electoral district of Westmount-St. Henri which shall consist of the town of Westmount, St. Henri and Ste. Cunégonde wards of the city of Montreal. The part of St. Gabriel ward north of the Grand Trunk Railway tracks, which formerly belonged to the county of Hochelaga, shall be transferred to the electoral district of Jacques Cartier, and the part of St. Gabriel ward south of the Grand Trunk Railway tracks, which also belonged to the county of Hochelaga, shall be transferred to the electoral district of St. Ann.
- (j) The electoral district of St. Antoine which shall be composed of St. Andrew's and St. Joseph wards in the city of Montreal.

(k) The electoral district of St. Lawrence-St. George which shall comprise St. Lawrence and St. George wards

of the city of Montreal.

- (l) The electoral district of Maisonneuve which shall comprise the town of Maisonneuve, Rosemount ward and Longue point ward of the city of Montreal, Pointe-aux-Trembles town and parish, Rivière-des-Prairies, Sault au Recollet town and parish, St. Léonard-de-Port-Maurice, the town of Montréal Est, the town of St. Michel-de-Laval and the area on which is situated the St. Jean-de-Dieu hospital.
- 11. The parish of St. Marcel in the county of Richelieu shall be transferred to the electoral district of Yamaska.
- 12. The parish called L'Ascension in the county of Mont-calm shall be transferred to the electoral district of Labelle.

- 13. The two counties of L'Assomption and Montcalm shall be united and shall form one electoral district less the parish of L'Ascension above referred to which is transferred to Labelle. The said two counties of L'Assomption and Montcalm so arranged shall form one electoral district to be called L'Assomption-Montcalm, and shall return one member.
- 14. The two electoral districts of Wright and Labelle shall be divided into three electoral districts returning each one member as follows:
- (a) The electoral district of Hull, which shall consist of Hull city, East and West Hull, Gatineau Point, East and West Templeton, the town of Buckingham, the township of Buckingham, L'Ange Gardien, Portland East and West, Derry, Bowman, Villeneuve East and West, Blake, McGill, Bigelow, Wells, Wabasee and Dudley.
- (b) The electoral district of Labelle which shall be constituted as at present less the town of Buckingham, the township of Buckingham, L'Ange Gardien, Portland East and West, Derry, Bowman, Villeneuve East and West, Blake, McGill, Bigelow, Wells, Wabasee and Dudley which are transferred to the new electoral district of Hull.
- (c) The electoral district of Wright which shall be constituted as at present less Hull city, East and West Hull, Gatineau Point, East and West Templeton, which are transferred to the new electoral district of Hull.
- 15. The counties of St. Hyacinthe and Rouville shall be united into one electoral district returning one member, and shall be called St. Hyacinthe-Rouville.
- 16. The electoral district of Chicoutimi-Saguenay which shall be constituted as at present together with that portion of the province of Quebec which was added to the said province and described in section 2 of chapter 45 of the statutes of 1912.

NOVA SCOTIA.

The electoral districts of the province of Nova Scotia shall continue to be constituted and represented in the House of Commons, as at present, except in the following particulars:—

- 1. The county of Annapolis and the county of Digby without the municipality of Clare which is to be detached from said county of Digby, shall together form and constitute the electoral district of Digby and Annapolis, and shall return one member.
- 2. The county of Antigonish and the county of Guysborough shall together form and constitute the electoral 338 district

district of Antigonish and Guysborough, and shall return one member.

- 3. The electoral district of South Cape Breton and thecounty of Richmond shall together form and constitute the electoral district of South Cape Breton and Richmond, and shall return two members.
- and shall return two members.

 4. The county of Yarmouth with the municipality of Clare which is now comprised in the electoral district of Digby, shall together form and constitute the electoral district of Yarmouth and Clare, and shall return one member.

NEW BRUNSWICK.

There shall be in the province of New Brunswick ten electoral districts, defined as follows:—

- 1. The county of Restigouche and the county of Madawaska shall together form and constitute the electoral district of Restigouche and Madawaska, and shall return one member.
- 2. The county of Victoria and the county of Carleton shall together form and constitute the electoral district of Victoria and Carleton, and shall return one member.
- 3. The county of York and the county of Sunbury shall together form and constitute the electoral district of York-Sunbury, and shall return one member.
- 4. The county of Kings and the county of Queens shall together form and constitute the electoral district of Royal, and shall return one member.
- 5. The city of St. John, the county of St. John and the county of Albert shall together form and constitute the electoral district of the city and counties of St. John and Albert, and shall return two members.
- 6. Excepting the counties and the city aforesaid, each of the other counties of the province, namely, Charlotte, Gloucester, Kent, Northumberland, and Westmoreland shall, under their respective names, form and constitute an electoral district, and shall each return one member.

PRINCE EDWARD ISLAND.

There shall be in the province of Prince Edward Island three electoral districts, defined as follows:—

- 1. The county of Kings shall form and constitute the electoral district of Kings, and shall return one member.
- 2. The county of Prince shall form and constitute the electoral district of Prince, and shall return one member.
- 3. The county of Queens shall form and constitute the electoral district of Queens, and shall return one member.

Provided that if the British North America Act, 1867, should be amended by the Parliament of the United Kingdom, in accordance with the address of both Houses of the Parliament of Canada in that behalf, passed at the present session, immediately upon the Act of the Parliament of the United Kingdom amending the said British North America Act, 1867, in accordance with such address, coming into force, there shall be in the province of Prince Edward Island three electoral districts defined as follows:—

- 1. The County of Kings shall form and constitute the electoral district of Kings and shall return one member;
- 2. The County of Prince shall form and constitute the electoral district of Prince, and shall return one member;
- 3. The County of Queens shall form and constitute the electoral district of Queens and shall return two members.

MANITOBA.

In the following descriptions, where "meridians between ranges" and "boundaries of townships" are referred to as the boundaries of electoral districts, these expressions mean the meridians and boundaries of townships in accordance with the Dominion lands system of surveys, and include the extension thereof in accordance with the said system.

There shall be in the province of Manitoba fifteen electoral districts, each of them to be represented by one member,

as follows:-

- 1. The electoral district of Brandon, bounded as follows:—Commencing at the intersection of the west boundary of the province of Manitoba with the north boundary of the sixth townships; thence easterly along said north boundary of the sixth townships to the meridian between the sixteenth and seventeenth ranges, west of the principal meridian; thence northerly along the said meridian between the sixteenth and seventeenth ranges west of the principal meridian to the north boundary of the twelfth townships; thence westerly along said north boundary of the twelfth townships to the said west boundary of the province of Manitoba; thence southerly along said west boundary of the province of Manitoba to the point of commencement.
- 2. The electoral district of Dauphin, bounded as follows:—Commencing at the intersection of the west boundary of the province of Manitoba with the north boundary of the twenty-sixth township; thence eastwardly along said north boundary of the twenty-sixth townships to the meridian between the twenty-fifth and twenty-sixth ranges, west of the principal meridian; thence southerly along said meridian between the twenty-fifth and twenty-fifth and 340

twenty-sixth ranges west of the principal meridian to the north boundary of the twenty-second townships: thence easterly along said north boundary of the twentysecond townships to the east shore of lake Manitoba in the tenth range west of the principal meridian; thence northerly along said east shore of the said lake Manitoba to the most northerly shore of the said lake in the thirtysecond township in the tenth range; thence westerly along said north shore of said lake Manitoba where it is bounded by the north boundary of the thirty-first township in the eleventh range: thence westerly along said north boundary of the thirty-first township in the eleventh range west of the principal meridian to the meridian between the eleventh and twelfth ranges west of the principal meridian; thence northerly along said meridian between the eleventh and twelfth ranges west of the principal meridian to the north boundary of the thirty-second townships; thence westerly along said north boundary of the thirty-second townships to the west boundary of the province of Manitoba; thence southerly along said west boundary of the province of Manitoba to the point of commencement.

3. The electoral district of Lisgar, bounded as follows:— Commencing at the intersection of the south boundary of the province of Manitoba with the meridian between the thirteenth and fourteenth ranges west of the principal meridian; thence easterly along said south boundary of the said province to the Red River; thence along said Red River down stream to where the said Red River is intersected by the north boundary of the second townships: thence westerly along said north boundary of the second townships to the principal meridian; thence northerly along said principal meridian to the north boundary of the third townships; thence westerly along said north boundary of the third townships to the meridian between the second and third ranges west of the principal meridian; thence northerly along the said meridian between the second and third ranges west of the principal meridian to the north boundary of the fourth townships; thence westerly along said north boundary of the fourth townships to the meridian between the thirteenth and fourteenth ranges west of the principal meridian; thence southerly along said meridian between the thirteenth and fourteenth ranges west of the principal meridian to the point of commencement.

4. The electoral district of Macdonald, bounded as follows:—Commencing at the intersection of the meridian between the thirteenth and fourteenth ranges west of the principal meridian with the north boundary of the fourth townships; thence easterly along said north boundary of the fourth townships to the meridian between the second

The electoral district of Marquette, bounded as follows:—Commencing at the west boundary of the province of Manitoba where it is intersected by the north boundary of the twelfth townships; thence easterly along said north boundary of the twelfth townships to the meridian between the sixteenth and seventeenth ranges west of the principal meridian; thence northerly along said meridian between the sixteenth and seventeenth ranges west of the principal meridian to the north boundary of the twenty-second townships; thence westerly along said north boundary of the twenty-second townships to the meridian between the twenty-fifth and twenty-sixth ranges west of the principal meridian; thence northerly along said meridian between the twenty-fifth and twenty-sixth ranges west of the principal meridian to the north boundary of the twenty-sixth townships; thence westerly along said north boundary of the twenty-sixth townships to the west boundary of said province of Manitoba; thence southerly along said west boundary of the said province of Manitoba to the point of commencement.

6. The electoral district of Neepawa, bounded as follows:
—Commencing at the intersection of the meridian between the sixteenth and seventeenth ranges west of the principal meridian with the north boundary of the ninth townships; thence easterly along said north boundary of the ninth townships to the meridian between the ninth and tenth ranges west of the principal meridian; thence northerly along said meridian between the ninth and tenth ranges west of the principal meridian to the north boundary of the fourteenth townships; thence easterly along said north boundary of the fourteenth townships to the southwest shore of lake Manitoba where said southwest shore is intersected by the meridian between the eighth and ninth ranges west of the principal meridian; thence southeasterly, easterly and

and northeasterly along the south shore of said lake Manitoba to its most easterly point in the fourth range west of the principal meridian; thence northwesterly along said east shore of said lake to the north boundary of the twentysecond townships: thence westerly along said north boundary of the twenty-second townships to the meridian between the sixteenth and seventeenth ranges west of the principal meridian; thence southerly along said meridian between the sixteenth and seventeenth ranges west of the principal

meridian to the point of commencement.

7. The electoral district of Nelson, bounded as follows:— Commencing at the intersection of the west boundary of the province of Manitoba with the north boundary of the thirtysecond townships: thence easterly along said north boundary of the thirty-second townships to the meridian between the eleventh and twelfth ranges, west of the principal meridian; thence northerly along said meridian between the eleventh and twelfth ranges west of the principal meridian to a point where the shore of lake Winnipeg is intersected by the said meridian between the eleventh and twelfth ranges west of the principal meridian near the fifty-third parallel of latitude: thence northwesterly and northerly along the west shore of said lake Winnipeg to its most northern shore; thence easterly along said north shore of said lake Winnipeg; thence southerly along the east shore of said lake Winnipeg to a point where it is intersected by the north boundary of the province of Manitoba as that boundary is defined by section 1 of chapter 14 of the statutes of 1881; thence easterly along said north boundary to the northeast corner of said north boundary of the said province as defined by section 1 of chapter 14 of the statutes of 1881; thence northeasterly along the north east boundary of said province to the north boundary of the said province as that boundary is defined by section 3 of chapter 32 of the statutes of 1912; thence northwesterly along said north boundary of said province of Manitoba as that boundary is defined by section 3 of chapter 32 of the statutes of 1912; thence westerly along said north boundary to the northwest corner of the west boundary of said province of Manitoba; thence southerly along said west boundary to the point of commencement.

8. The electoral district of Portage la Prairie, bounded as follows:—Commencing at the intersection of the meridian between the ninth and tenth ranges west of the principal meridian with the north boundary of the ninth townships; thence easterly along said north boundary of the ninth townships to the rear line of lots in the outer two miles of the parishes of St. Norbert and St. Vital; thence in a northeasterly and northerly direction along said rear line of lots in the outer two miles of the said parish of St. Vital (the said parish

The electoral district of Provencher, bounded as follows:--Commencing at the south boundary of the province of Manitoba where said south boundary is intersected by the Red River in the second range east of the principal meridian; thence easterly along the said south boundary of said province to the southeast corner of the east boundary of said province of Manitoba; thence northerly along said east boundary of the said province of Manitoba to the north boundary of the sixth townships; thence westerly along the said north boundary of the sixth townships to the rear line of lots fronting on the west side of said Red River in the parish of Ste. Agathe; thence in a northerly direction along said rear line and along the rear line of lots in the parish of St. Norbert to the south limit of lots in the outer two miles of said parish of St. Norbert; thence southwesterly along said south limit to the rear line of said lots in the outer two miles of the parish of St. Norbert to the north boundary of the ninth townships; thence westerly along said north boundary 344

of the ninth townships to the meridian between the second and third ranges west of the principal meridian; thence southerly along said meridian between the second and third ranges, west of the principal meridian to the north boundary of the third townships; thence easterly along said north boundary of the third townships to the principal meridian; thence southerly along said principal meridian to the north boundary of the second townships; thence easterly along said north boundary of the second townships to the said Red River; thence along said Red River up stream to the point of commencement.

10. The electoral district of Selkirk bounded as follows:— Commencing at the intersection of the meridian between the third and fourth ranges west of the principal meridian with the north boundary of the twelfth townships; thence easterly along said north boundary of the twelfth townships to the rear line of the outer two miles of the parishes of St. Andrews and St. Pauls on the west side of the Red River; thence southerly and along the said rear line of the outer two miles of the parishes of St. Pauls and Kildonan to the northwest corner of the electoral division of Winnipeg north as that division is defined in an Act to amend "The Electoral Divisions Act" of the province of Manitoba which has been passed by the Legislative Assembly of said province and assented to upon the twentieth day of February last (1914); thence southeasterly to Red River; thence along the said Red River down stream to where the said Red River empties into lake Winnipeg; thence easterly and northerly along the south and east shores of said lake Winnipeg to its most northerly limit; thence westerly along the north shore of said lake Winnipeg; thence southerly along the west shore of the north part of said lake; thence southeasterly to the production of the meridian between the eleventh and twelfth ranges west of the principal meridian; thence southerly along said meridian between the eleventh and twelfth ranges west of the principal meridian to the north boundary of the thirty-first townships; thence easterly along the north boundary of the thirty-first townships to its intersection with the north shore of lake Manitoba; thence easterly and southerly along the north and east shores of said lake Manitoba to the north boundary of the seventeenth townships; thence easterly along said north boundary of the seventeenth townships to the meridian between the third and fourth ranges west of the principal meridian; thence southerly along said meridian between the third and fourth ranges west of the principal meridian to the point of commencement.

11. The electoral district of Springfield, bounded as follows:—Commencing at the intersection of the rear line of lots fronting on the west side of the Red River

in the parish of Ste. Agathe with the north boundary of the sixth townships: thence easterly along the said north boundary of the sixth townships to the east boundary of the province of Manitoba as that boundary is defined in section 1 of chapter 14 of the statutes of 1881 of the province of Manitoba; thence northerly along the said east boundary of the said province to the north boundary of the fortyfourth townships at the northeast angle of the north boundary of said province as that boundary is defined in the said statutes of 1881; thence westerly along said north boundary of the forty-fourth townships to the east shore of lake Winnipeg in the first range east of the principal meridian; thence southerly along the said east shore of said lake Winnipeg to where the Red River empties into the said lake Winnipeg; thence along the said Red River up stream to the northeast angle of the north boundary of the city of Winnipeg as that boundary is defined in an Act to amend "The Electoral Divisions Act" of the province of Manitoba which was assented to upon the twentieth day of February last (1914); thence along the said Red River up stream to the southeast angle of the south boundary of the city of Winnipeg as that boundary is defined in said statutes of 1914; thence in a southwesterly direction to the rear line of lots fronting on the west side of the Red River in the parish of St. Boniface thence southerly along the said rear line of lots in the parishes of St. Boniface and St. Norbert—but exclusive of the parish of St. Vital as hereinafter defined to be constituted in the electoral division of Winnipeg South—to the point of commencement.

12. The electoral district of Souris, bounded as follows:— Commencing at the southwest corner of the province of Manitoba being the point of intersection of the meridian between the twenty-ninth and thirtieth ranges west of the principal meridian with the international boundary; thence easterly following the international boundary line, being the south boundary of the province of Manitoba, to its intersection with the meridian between the thirteenth and fourteenth ranges west of the principal meridian; thence northerly along said meridian between the thirteenth and fourteenth ranges west of the principal meridian to the north boundary of the sixth townships; thence westerly along said north boundary of the sixth townships to its intersection with the meridian between the twenty-ninth and thirtieth ranges west of the principal meridian, being the west boundary of the province of Manitoba; thence following southerly along the west boundary of said province of Manitoba to the point of commencement.

13. The city of Winnipeg shall be divided into three electoral divisions, each of them to be represented by one member, as follows:—

- (a) The electoral division of Winnipeg North to comprise all that portion of the city of Winnipeg included within the limits following, that is to say:—Commencing at the intersection of the northerly boundary of that portion of the said city west of the Red River with the centre line of the Red River: thence westerly along said northerly boundary to the westerly boundary of the said city; thence southerly along said westerly boundary to the centre of the main line of the Canadian Pacific Railway; thence southeasterly along the centre of the said main line of the Canadian Pacific railway to the centre line of the Red River; thence northerly along centre line of the Red River to its intersection with the southerly limit of the said city east of the Red River; thence easterly along the said southerly limit to the eastern limit of said city of Winnipeg; thence northerly along the easterly limit to the northerly limit of the said portion of the city of Winnipeg east of the Red River together with that portion of the city of Winnipeg designated as "Elmwood"; thence westerly along the said northerly limit to the centre line of the Red River: thence northerly along the said centre line to the point of commencement. Also all those portions of sections 14, 23, and 24, in township 11, range 2, east of the principal meridian and lot 35B of the parish of St. John, bounded as follows: On the north by the centre line of the road allowance, north of and adjoining the northerly limits of the said sections 23 and 24; on the south by the centre line of the Canadian Pacific Railway main line; on the east by the westerly limits of the city of Winnipeg, and on the west by the centre line of the road allowance west of and adjoining the westerly limit of the said section 23, township 11, range 2, east.
- (b) The electoral division of Winnipeg Centre to comprise all that portion of the city of Winnipeg, included within the limits of the following, that is to say:—Commencing at the intersection of the centre line of Portage Avenue East and its production with the centre line of the Red River; thence northeasterly and northwesterly along the centre line of the Red River to the centre line of the main line of the Canadian Pacific Railway; thence westerly along the centre of the said main line of the Canadian Pacific Railway to the centre line of the road allowance, west of and adjoining sections 14 and 23, township 11, range 2, east; thence southerly along said centre line to its intersection with the centre line of the road allowance south of and adjoining the southerly limit of the southeast quarter of section 15, township 11,

range 2, east; thence westerly along the said centre line to the point of intersection of the production northerly of the westerly limit of lot 20, in the outer two miles of the parish of St. James: thence southerly along the said westerly boundary of its production to the centre line of the two mile road allowance (Saskatchewan Avenue); thence southerly in a straight line to a point in the southerly limit of the two miles road allowance, equidistant between the easterly limit of river lot 19 and the westerly limit of river lot 20, of the parish of St. James: thence southerly along the centre line of the municipal road between the said parish lots 19 and 20 to the centre line of the Assiniboine River together with that portion of the said parish of St. James which is not comprised within the limits as above defined: thence easterly along the said centre line to the westerly limit of the city of Winnipeg, north of the Assiniboine River; thence northerly along the said westerly limit of the city of Winnipeg to the centre line of Portage Avenue: thence northeasterly along the said centre line of Portage Avenue and its production to the centre line of Main Street: thence southeasterly along the centre line of Portage Avenue East and its production to the point of commencement.

(c) The electoral division of Winnipeg South to comprise, Firstly: All that portion of the city of Winnipeg included within the limits following, that is to say:—Commencing at the intersection of the southerly boundary of the said city with the centre line of the Red River; thence northeasterly and northwesterly along the centre line of said Red River to the centre line of Portage Avenue East; thence westerly along the centre line of Portage Avenue East to the centre line of Main Street; thence westerly along the centre line of Portage Avenue to the westerly boundary of the said city; thence southerly along the said westerly boundary to the southerly boundary of the said city; thence easterly along the said southerly boundary to the place of beginning. Secondly: All of the town of Tuxedo: and Thirdly: All those portions of the rural municipalities of Fort Garry and St. Vital, bounded as follows:-On the north by the southerly limits of the city of Winnipeg, and the city of St. Boniface; on the south by the following described lines:—Commencing at the point of intersection of the southerly limit of river lot 123, of the parish of St. Norbert, produced with the centre line of the two mile road allowance (Waverly Street); thence easterly along the said southerly limit of river lot 123 to the water's edge of the Red River; thence southerly at right angles to the said southerly limit of river lot 123 to the centre line of the Red River; thence easterly along the said centre line to its intersection with the production westerly of the northerly boundary 348

boundary of river lot 126, of the parish of St. Norbert: thence easterly along the said northerly limit of river lot 126 to the centre line of the Seine River; on the west by the centre line of the two miles road allowance (Waverly Street) and on the east by the centre line of the Seine River together with that portion of the said parish of St. Vital which is not comprised within the limits as herein defined.

BRITISH COLUMBIA.

The provincial electoral districts are those referred to in Schedule "C" to the Constitution Act, being chapter 44 of the Revised Statutes of British Columbia, 1911.

There shall be in the province of British Columbia thirteen electoral districts, each of them to be represented

by one member, as follows:—

- 1. The electoral district of Comox-Alberni, comprising provincial electoral districts of Alberni, Comox, and all that portion of the provincial electoral district of Richmond bounded on the east by the east boundary of the said provincial electoral district of Richmond from the northeast corner thereof; thence southerly to the northwest corner of the provincial electoral riding of Dewdney; thence in a southwesterly direction to the mouth of the east branch of the Squamish river at the head of Howe Sound; thence in a southerly direction along the easterly shore of Howe sound to Burrard inlet.
- 2. The electoral district of East Kootenay, comprising the provincial electoral districts of Cranbrook, Fernie and Columbia.
- 3. The electoral district of West Kootenay, comprising the provincial electoral districts of Nelson City, Ymir, Rossland City, Slocan, Kaslo and Revelstoke.

4. The electoral district of Nanaimo, comprising the provincial electoral districts of Cowichan, Esquimalt, Nanaimo City, Newcastle, Saanich and The Islands.

- 5. The electoral district of New Westminster, comprising the provincial electoral districts of New Westminster City and Delta, and all that portion of the provincial district of Richmond lying south of Burrard inlet excepting the municipalities of Vancouver City, South Vancouver and Point Grey.
- 6. The electoral district of Westminster District, comprising the provincial electoral districts of Dewdney and Chilliwack, and all that portion of the provincial electoral district of Yale adjoining the provincial electoral districts of Chilliwack and Dewdney bounded by a line commencing at the southeast corner of the provincial electoral district of Chilliwack; thence easterly along the international 349 boundary

boundary to its point of intersection with the westerly boundary of the provincial electoral district of Similkameen; thence northerly following said last mentioned boundary to the northwest corner of the said provincial electoral district of Similkameen; thence in a straight line westerly to a point on the north bank of the Fraser river one mile east of the village of Yale; thence following a straight line to the northeast corner of the provincial electoral district of Dewdney.

- 7. The electoral district of Vancouver Centre, comprising ward one of the city of Vancouver together with Stanley Park, and wards two, three and four of the said city of Vancouver.
- 8. The electoral district of Burrard, comprising wards five, six, seven and eight of the city of Vancouver and that portion of the provincial electoral district of Richmond which lies within the following described limits, that is to 'say:—Commencing at the northwest corner of the provincial electoral district of Dewdney; thence in a southwesterly direction to the mouth of the east branch of the Squamish river at the head of Howe Sound; thence in a southerly direction along the easterly shore of Howe Sound to Burrard inlet; thence in an easterly direction along the northerly shore of Burrard Inlet and in a northerly direction along the westerly shore of North Arm of the said Burrard Inlet to the northerly extremity of the said North Arm, and northerly to the point of commencement.

9. The electoral district of Vancouver South, comprising the municipalities of South Vancouver and Point Grev.

10. The electoral district of Skeena, comprising the provincial electoral districts of Skeena and Atlin.

11. The electoral district of Victoria City, comprising

the provincial electoral district of Victoria City.

12. The electoral district of Cariboo, comprising the provincial electoral districts of Cariboo, Lillooet, Kamloops and Yale excepting that portion of Yale contained in the electoral district of Westminster District as the same is above described, and including the whole city, and district municipality of Salmon Arm.

13. The electoral district of Yale, comprising the provincial electoral district of Okanagan, excepting any portion of the city or district municipality of Salmon Arm which may be contained therein, and the provincial electoral districts of Similkameen, Greenwood and Grand Forks.

SASKATCHEWAN.

In the following descriptions, where "meridians between ranges" and "boundaries of townships" are referred to as 350 the

the boundaries of electoral districts, these expressions mean the meridians and boundaries of townships in accordance with the Dominion lands system of surveys, and include the extension thereof in accordance with the said system.

There shall be in the province of Saskatchewan sixteen

electoral districts, defined as follows:—

The said electoral district of Assiniboia shall return one member.
- 2. The electoral district of Qu'Appelle, bounded as follows:—Commencing at the east boundary of the province of Saskatchewan where it is intersected by the north boundary of the eleventh township; thence northerly along the said east boundary of the province of Saskatchewan to the Qu'Appelle river; thence along the Qu'Appelle river up stream to the meridian between the sixteenth and seventeenth ranges west of the second meridian; thence southerly along the said meridian between the sixteenth and seventeenth ranges west of the second meridian to the north boundary of the fifteenth townships: thence easterly along the said north boundary of the fifteenth townships to the meridian between the tenth and eleventh ranges west of the second meridian; thence southerly along the said meridian between the tenth and eleventh ranges west of the second meridian to the north boundary of the eleventh townships; thence easterly along the north boundary of the eleventh townships to the point of commencement. The said electoral district of Qu'Appelle shall return one member.
- 3. The electoral district of Weyburn, bounded as follows:—Commencing at the south boundary of the province of Saskatchewan where it is intersected by the meridian between the tenth and eleventh ranges west of the second meridian; thence northerly along the said meridian between the tenth and eleventh ranges west of the second meridian to the north boundary of the fifteenth townships; thence westerly along the north boundary of the fifteenth townships to the meridian between the twenty-first and twenty-

- 4. The electoral district of Regina, bounded as follows:— Commencing at the intersection of the meridian between the sixteenth and seventeenth ranges west of the second meridian with the north boundary of the fifteenth townships: thence northerly along the said meridian between the sixteenth and seventeenth ranges west of the second meridian to the Qu'Appelle river; thence along the Qu'Appelle river up stream to a point where the Canadian Pacific railway crosses the said Qu'Appelle river in the twentieth township in the twenty-first range west of the second meridian; thence northwesterly along the said Canadian Pacific railway to Last Mountain lake at the north boundary of the said twentieth township in the twenty-first range west of the second meridian; thence northwesterly along the centre of Last Mountain lake to the north boundary of the twenty-second townships; thence westerly along the north boundary of the twenty-second townships to the meridian between the first and second ranges west of the third meridian; thence along the Qu'Appelle river down stream to Buffalo Pound lake; thence southeasterly along the centre of Buffalo Pound lake to where the Qu'Appelle river flows out of the said lake towards the east; thence along the Qu'Appelle river down stream to its most easterly intersection with the north boundary of the eighteenth townships; thence southerly along the meridian between the twenty-fourth and twenty-fifth ranges west of the second meridian to the north boundary of the fifteenth townships; thence easterly along the north boundary of the fifteenth townships to the point of commencement. The said electoral district of Regina shall return one member.
- 5. The electoral district of Moosejaw, bounded as follows:—Commencing at the south boundary of the province of Saskatchewan where it is intersected by the meridian between the twenty-first and twenty-second ranges west of the second meridian; thence northerly along the said meridian between the twenty-first and twenty-second ranges west of the second meridian to the north boundary of the fifteenth townships; thence westerly along the said north boundary of the fifteenth townships to the meridian between the twenty-fourth and twenty-fifth ranges west of the second meridian; thence northerly along the said meridian 352

meridian between the twenty-fourth and twenty-fifth ranges west of the second meridian to the Qu'Appelle river; thence along the Qu'Appelle river up stream to Buffalo Pound lake; thence northwesterly along the said Buffalo Pound lake to where the said lake is entered from the west by the Qu'Appelle river; thence along the said Qu'Appelle river up stream to a point where the said Qu'Appelle river is intersected by the third meridian; thence south along the said third meridian to the south boundary of the province of Saskatchewan; thence easterly along the said south boundary of the said province to the point of commencement. The said electoral district of Moose-

jaw shall return one member.

6. The electoral district of Swift Current, bounded as follows:-Commencing at the intersection of the third meridian with the north boundary of the eighth townships: thence northerly along the said third meridian to the Qu'Appelle river; thence along the said Qu'Appelle river up stream to its source in the twenty-third township in the fourth range west of the third meridian; thence along Aitkow creek down stream to the South Saskatchewan river; thence westerly along the South Saskatchewan river up stream to the north boundary of the twentieth township where the meridian between the seventeenth and eighteenth ranges west of the third meridian intersects the said South Saskatchewan river; thence south along the said meridian between the seventeenth and eighteenth ranges west of the third meridian to the north boundary of the eighth townships; thence easterly along the north boundary of the eighth townships to the point of commence-The said electoral district of Swift Current shall return one member.

7. The electoral district of Maple Creek, bounded as follows:—Commencing at the south boundary of the province of Saskatchewan where it is intersected by the third meridian; thence north along the said third meridian to the north boundary of the eighth township; thence westerly along the said north boundary of the eighth townships to the meridian between the seventeenth and eighteenth ranges west of the third meridian; thence northerly along the said meridian between the seventeenth and eighteenth ranges west of the third meridian to the South Saskatchewan river; thence westerly along the South Saskatchewan river up stream to the west boundary of the province of Saskatchewan where the fourth meridian intersects the South Saskatchewan river in the twenty-third township; thence south along the said west boundary of the province of Saskatchewan to the southwest corner of the said province; thence east along the said south boundary of the province of Saskatchewan to the point of commencement. The said electoral district

of Maple Creek shall return one member.

- 8. The electoral district of Saskatoon, bounded as follows:—Commencing at the intersection of the meridian between the first and second ranges west of the third meridian with the north boundary of the thirty-fourth townships: thence northerly along the said meridian between the first and second ranges west of the third meridian to the north boundary of the forty-first townships; thence westerly along the north boundary of the said forty-first townships to the North Saskatchewan river in the seventh range west of the third meridian; thence along the said North Saskatchewan river up stream to the northwest corner of the fortysecond township where it is intersected by the meridian between the fifteenth and sixteenth ranges west of the third meridian; thence southerly along the said meridian between the fifteenth and sixteenth ranges west of the third meridian to the north boundary of the thirty-third townships; thence easterly along the north boundary of the said thirty-third townships to the South Saskatchewan river in the sixth range west of the third meridian; thence along the said South Saskatchewan river down stream to the north boundary of the thirty-fourth township in the said sixth range west of the third meridian; thence easterly along the said north boundary of the thirty-fourth townships to the point The said electoral district of Saskatoon of commencement. shall return one member.

The said electoral district of North Battleford shall return one member.

ALBERTA.

In the following descriptions, where "meridians between ranges" and "boundaries of townships" are referred to as the boundaries of electoral districts, these expressions mean the meridians and boundaries of townships in accordance with the Dominion lands system of surveys, and include the extension thereof in accordance with the said system.

There shall be in the province of Alberta twelve electoral districts, each of them to be represented by one member, defined as follows:—

The electoral district of East Edmonton, bounded as follows:—Commencing at the intersection of First Street, in the city of Edmonton, as the said street is shown on the registered plans of the said city, with the north bank of the North Saskatchewan river; thence northerly along First Street aforesaid to Algonquin Avenue as such avenue is shown on the registered plans of the said city, being the north boundary of the said city of Edmonton, as the city is at present bounded; thence westerly along Algonquin Avenue aforesaid to the meridian between the twentyfourth and twenty-fifth ranges west of the fourth meridian; thence northerly along the said meridian between the twenty-fourth and twenty-fifth ranges west of the fourth meridian to the north boundary of the sixty-eighth townships; thence westerly along the said north boundary of the sixty-eighth townships to the fifth meridian; thence northerly along the fifth meridian to the north boundary of the province of Alberta: thence easterly along the north boundary of the province of Alberta to the east boundary of the said province: thence southerly along the east boundary of the province of Alberta to the north boundary of the sixtyninth townships; thence westerly along the said north boundary of the sixty-ninth townships to the intersection thereof with the meridian between the ninth and tenth ranges west of the fourth meridian; thence southerly along the said meridian between the ninth and tenth ranges west of the fourth meridian to the North Saskatchewan river: thence along the North Saskatchewan river up stream to the point of commencement.
